

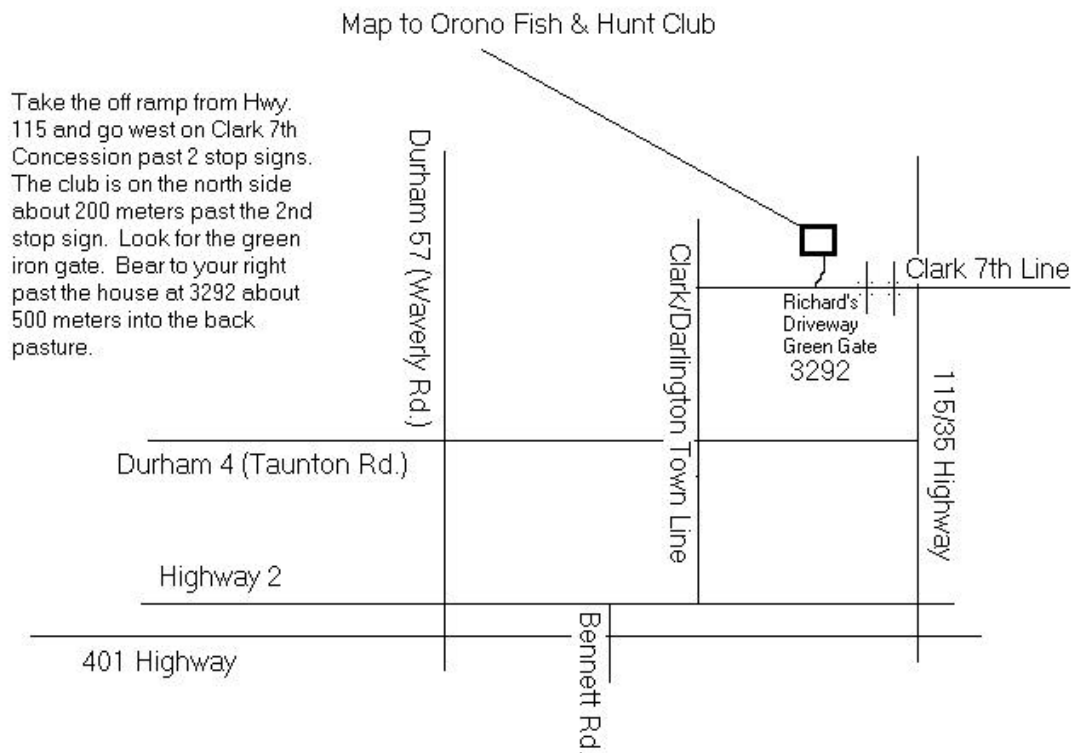

Fourth Annual Canadian 1800 Handgun Competition

Date: Saturday, June 10^h, 2004 9:00 A.M. with a pre-fire date on Friday June 9^h 9:00 A.M. for the range officers and those who cannot attend on the 10^h. Shooters for June 9^h must pre-register, no walk-ons. Pre-registration is recommended to ensure the relay of your choice.

Location: The Orono Fish & Hunt Club is located at 3292 Concession 7, Clarke Township. From Highway 115 take the off ramp at Kirby and go west past 2 stop signs. 3292 is on the north side approx. 200 meters west from the intersection of Leskard Road. As you enter the driveway, bear to your right.

There are only 12 shooting positions so with 4 relays, we can only accommodate 48 shooters in all, so get your entry forms A.S.A.P. There will be no walk-ons for the Friday (pre-shoot) day. You must pre-register if you want to shoot on this date.

- Scoring:** Scoring will be done by the competitors on the line. Score cards will be passed to the left and competitors will score the target to their right.

- Food:** There will be a BBQ (hamburgers and sausages) during the lunch break at/or about 12:00 P.M. for a nominal fee. No alcoholic beverages allowed on the range property.

The above course of fire is fired first with .22 rim fire handguns and then the course is repeated with centre fire handguns. Requirements are 90 rounds of .22 and 90 rounds of centre fire ammunition.
